#### **DESIGNATED FUNDS**

#### The Conrad and Kathryn Church Landscaping Fund

The Village of Andover recently received a grant check for \$4,640.82 from the Conrad and Kathryn Church Landscaping Endowment Fund which is managed by the Allegany County Area Foundation. This grant money will be used for tree pruning in the village of Andover.





# **The Scio Free Library Receives Hydramec Grant**

The Allegany County Area Foundation presented a \$598.57 check to the Scio Memorial Library. This check comes from the current earnings of an ACAF endowment fund established by the Hydramec Corporation in Scio back in 1989.

#### **Susan Foster Myers Fund**

The Allegany County Area Foundation recently awarded a \$154.02 grant to the Friendship Free Library. Michelle Hill, Director of the Friendship Free Library, said that the money would be used to purchase new curtains for the Children's Room the library. This award was made possible from the earnings of the Susan Foster Myers Memorial Endowment Fund.





#### The NEA Receives ACAF Grant

The National Eczema Association (NEA) recently received a \$432.44 grant check from the Jonathan A. Dahlgren Eczema Fund which is managed by the Allegany County Area Foundation. Julie Block, CEO of the NEA, said, "This grant money will help them to advance eczema research while providing our community with the information, resources and support to live well."

#### **Richburg-Wirt Historical Society Receives Bartoo Grant**

The Allegany County Area Foundation recently presented a check for \$4,240 to the Richburg-Wirt Historical Society (RWHS). This money comes from the earnings of a fund created by the estate of Beatrice S. Bartoo who passed away in 2009. She and her husband Francis founded the Richburg-Wirt Historical Society in 2001.





#### **The Andover Free Library Receives ACAF Grant**

The Allegany County Area Foundation recently awarded a \$190.56 grant to the Andover Free Library. This award was made possible from the earnings of the Doris O. Church Fund held by the Foundation since 1999. These annual grant awards are used to provide financial assistance for the Andover Free Library.

#### **Scio Central School**

The Allegany County Area Foundation, recently presented a check for \$1,500 to the Scio Central School. This grant money will help support a summer swim program for the students attending the Scio Central School. Cristy McKinley, Director of Curriculum & Instruction, has been working closely with the YMCA and district personnel to set up the Scio summer swim program. This program will promote the development of swimming as a life skill.





#### **Leadership Allegany**

The Allegany County Area Foundation awarded a \$600 grant to Leadership Allegany. This money will be used to sponsor a participant in the Leadership Allegany Program. On hand to accept the award was Laura Hunsberger, a participant in the 2018 Leadership Allegany cohort. Laura is the executive director of the Cornell Cooperative Extension of Allegany County.

#### **Cuba Circulating Library**

The Allegany County Area Foundation awarded a \$340 grant from the Thomas F. and Laura L. Moogan Family Fund to the Cuba Circulating Library. The grant money will be used to help fund an early literacy program to benefit the Cuba community. Marsha Long, a trustee on the Cuba Circulating Library Board, said that their library will coordinate with a local pediatrician to distribute early literacy kits to 75 newborns and 75 kits to one year-olds. This program will allow them to reach out to parents and juvenile readers long before preschool age.





#### **Canaseraga Central School**

The Canaseraga Central School received a grant check for \$450 from the Allegany Fund which is managed by the Allegany County Area Foundation. This grant money will be used to help support their Laundry Life Skills Project, a program to help students with disabilities develop functional skills that will increase their autonomy and their ability to lead independent lives.



#### **Cribs for Kids Program**

The Allegany County Area Foundation awarded a \$500 grant to the Southern Tier Health Care System to help with their Cribs for Kids Program. This program was established in 2016 with support from the Allegany County Area Foundation. Primarily an education program, Cribs for Kids promotes infant safe sleep by providing training and a Pack'n Play crib to parents who, otherwise, would be unable to afford a safe place for their baby to sleep. The goal of Cribs for Kids is to prevent infant deaths due to unsafe sleep practices.

#### **Allegany County Historical Society**

The ACAF presented a \$1,000 grant to the Allegany County Historical Society. This grant money will be used to help support their Allegany County History Awareness Week Program scheduled for the last week in September of 2018. The money came from the Bob Christian Fund and the Allegany Fund.

#### **Alfred Box of Books Library**

The Alfred Box of Books Library received a grant from the Allegany County Area Foundation for an early literacy initiative which will be a collaborative effort with all of the libraries within our county. This initiative will be led by the Allegany County Public Library Directors Association. The grant money will help the libraries prepare an informational brochure on storytime or other literacy programs routinely held at each of the seventeen libraries around the county.

#### **Art for Rural America**

The Allegany County Area Foundation awarded a \$720 grant to Art for Rural America. This non-profit organization has build a new green space in an empty lot in Wellsville where the old Fassett hotel was located which is next to the former Pizza Hut building. They are calling this project, "The Fassett GreenSpace". The plans are to transform the vacant lot into a sculpture park for the public to explore. It will include a large-scale concrete meditation labyrinth created with 3 foot wide by 16 inch tall rounded garden beds. There will be a 3 foot wide path between the garden beds.



#### **Association for the Blind and Visually Handicapped**

The Allegany County Area Foundation recently awarded a \$500 grant to the Allegany County Association for the Blind and Visually Handicapped. They are partnering with the David A. Howe Library to enable those that are blind or with low vision to use the latest in audio visual technology. Kathryn Kirsch, director of the Blind Association, explained that this grant money was used to help purchase a DaVinci Pro desktop video magnifier which will be a benefit to the community. It allows the user to read with large print, and the device will also read the material to the user.



#### The Big Brothers, Big Sisters Programs



The Allegany County Area Foundation (ACAF) recently presented two \$350 checks to fund a Big Brothers, Big Sisters project at both the Genesee Valley Central School and the Whitesville Central School. This money comes from the Allegany Fund at the Foundation. Harmony Ayers-Friendlander, Executive Director of the Family Service Society, stated, "The Big Brothers, Big Sisters programs at the Genesee Valley and Whitesville locations are both positively impacting the lives of at-risk children by providing them with a caring mentor, extra-curricular education, lifeskills, and confidence – enabling them to succeed in school and life."

The Genesee Valley Big Brothers, Big Sisters program will use the ACAF grant money to fund an Extracurricular Art Enrichment initiative which will include four hands-on pottery classes taught by a local art teacher.

#### **The Alfred Montessori School**

The Alfred Montessori School received \$800.00 to help them improve the security of their building. This grant money will be used to help them purchase a new lockset and key fobs for their front entrance. Back in 2016 the school had made an investment for the health and safety of their children, staff and families by securing their rear entrance. Now both entrances will have a secure access.



#### **Genesee Valley Central School**

The Genesee Valley Central School Drama Club received a grant check for \$1,400 from the Allegany Endowment Fund which is managed by the Allegany County Area Foundation. This grant money will be used to help revitalize the dramatic arts at the Genesee Valley Central School. Jean Vallance, GVCS Drama Club Co-Advisor stated, "Our drama program as designed will strive to represent the "A" portion of the district's STEAM initiative. It will also further enhance and develop 21st Century skills – collaboration, creativity, communication and critical thinking – across multiple grade levels."



#### **Cuba Friends of Architecture & Cuba Circulating Library**





The Allegany County Area Foundation recently awarded a \$500 grant to both the Cuba Circulating Library and the Cuba Friends of Architecture. These two non-profit organizations will both use the money to help them purchase an automated external defibrillator (AED). An AED is a portable system that checks the heart rhythm and can send an electric shock to the heart to try to restore a normal rhythm. Sudden cardiac arrest is a condition in which the heart suddenly and unexpectedly stops beating.

Dr. Michael Doyle, President of the Cuba Friends of Architecture, explained that their AED will be placed in the performance area of the Palmer Opera House. The AED will also be available to the businesses located on the first floor of the building.

Leah Weber, the Cuba Circulating Library Director, said they would advertise their location as an AED site which will not only benefit their patrons, but the community at large. The library also plans to offer free training to all library staff and volunteers,


