

### **DESIGNATED GRANT FUNDS**



### Hydramec Grant Supports Scio Memorial Library

The Allegany County Area Foundation presented a \$596.40 check to the Scio Memorial Library. This support comes from the earnings from an endowment established by the Hydramec Corporation. The library anticipates using this most recent gift for a facilities project.

### Susan Foster Myers Fund Supports Friendship Library

The Allegany County Area Foundation awarded a \$266.86 grant to the Friendship Free Library. Michelle Hill, Library Director, reported that the money would be used to purchase holiday-themed materials. The Susan Foster Myers Fund was established by the Myers family as a memorial to Susan and her life of service.





### **ACAF Grant Supports NEA**

The National Eczema Association (NEA) received a \$518.22 grant from the Jonathan A. Dahlgren Eczema Fund. Julie Block, CEO of the NEA, said, "This grant money will help advance eczema research while providing our community with the information, resources and support to live well."

### **Historical Society Receives Bartoo Grant**

The Allegany County Area Foundation recently presented a check for \$4,381.96 to the Richburg-Wirt Historical Society (RWHS). This support comes from the earnings of a fund created by the estate of Beatrice S. Bartoo. She and her husband Francis founded the Historical Society in 2001.



### **Church Grant Aids Andover Library**

The Allegany County Area Foundation awarded a \$199.59 grant to the Andover Free Library. This award was made possible by the earnings of the Doris O. Church Fund, held by the Foundation since 1999. These annual grants support the library's collection, programs, and facilities.

Designated funds such as these are established by donors to benefit a specific organization

### Wellsville Montessori School

The Allegany County Area Foundation presented a \$750 grant to the Wellsville Montessori School. The funds will be devoted to upgrading school security through the installation of automatic locking and electronic access systems on the main entrance doors.

These enhancements mirror those being implemented at public and private schools nationally.

This support came via ACAF's Allegany Fund, through which the Foundation assists Allegany County non-profits.


Founded in 1982 and in its current facility since 2005, WMS is open year round and serves 50-60 children annually through its pre-school, before- and after-school day care, and spring and summer camp programs. The school enjoys strong and steady leadership.



The Allegany Fund is an unrestricted endowment established by the foundation. Earnings from this fund are used to support non-profit organizations as they serve communities throughout Allegany County

### Shake on the Lake

The Allegany County Area Foundation provided a \$900 grant to bring Shakespeare's As You



*Like It* to Allegany County. This free show, performed by innovative professional theater company Shake on the Lake and tweaked slightly for a modern audience and casual outdoor venue, was held on the lawn of the David A. Howe Library.

Wellsville resident Kathryn Ross enjoyed a SOTL show last year and worked to bring them to the county. Along with ACAF,

support came from the Wellsville Rotary, David A. Howe Library, the Lions Club, the Allegany Arts Association, and several individual donors.

Shake on the Lake (<u>www.shakeonthelake.org</u>) is a Perry, NY-based organization that brings professional-quality theater and arts education to rural communities, schools, and underserved populations, including the incarcerated, in a five-county area.

### Wide Awake Club (Fillmore Library)

The Allegany County Area Foundation provided a \$500 grant to the Fillmore Wide Awake Club to support its innovative *Escape to the Library* after-school program.

Created for 5-12<sup>th</sup> graders in collaboration with Fillmore Central School, *Escape to the Library* offers an hour of age-appropriate activities, after which students can take the FCS late bus home. The program currently runs two afternoons per week, though students can take advantage of regular library services and catch the FCS late bus on the other school days.

The *Escape* curriculum includes enrichment in the STEAM (STEM fields plus art) subjects, along with a good overall introduction to the library's offerings. The program has been well-

received by students, and by parents who appreciate their children having this safe, positive place to spend the gap time between the ends of the school and work days.

Library staff will assess the program and community needs with an eye toward providing additional days or areas of programming.



### Alfred Farmers Market

The Allegany County Area Foundation awarded the Alfred Farmers Market (AFM) a grant of \$500 to support the Market's Family Activities Tent.

Founded in 2010 and open Sundays from 11am-3pm, the Farmer's Market has quickly become a popular Alfred tradition. The Foundation grant allowed AFM board member/tent coordinator Allecia Brutsman to purchase new materials and supplies.

The Family Tent program features a variety of hands on, educational, and nature-related activities. While kid-centered, the tent has proven to be of interest to adults and in practice serves entire families. Ten to fifteen visitors stop in on a typical Sunday – with many more on AFM festival days.

Ms. Brutsman reports that the expanded curriculum has been popular. "People look forward to it", she notes, "it's been good for the community." Her engaging programming has also caught the attention of nearby communities that have contacted her to express interest in creating a similar space for their events.

### Allegany County Association for the Blind and Visually Handicapped

The Allegany County Area Foundation recently awarded \$350 to the ACABVH to support amblyopia screening for the county's pre-k classrooms. Studies have shown that early screening and intervention leads to better health and educational outcomes for children and is most cost effective from a public health standpoint.

### **Family Service Society**

The Allegany County Area Foundation recently presented a grant of \$850 to Family Service Society to support the agency's youth mentoring programs at Genesee Valley and Whitesville central schools.

According to FSS Youth Services Director Mike Foster, the grant will be used to fund both a



mural project at Genesee Valley and pottery classes at Whitesville. "Genesee Valley used last year's funding for pottery classes, and the children loved it," Foster noted. "We wanted to give Whitesville students that same opportunity. Both programs," he added, "will use the funding for yoga classes. This is a brand new opportunity for our youth to learn important coping skills and relaxation techniques."

The GVCS and WCS mentoring programs are expected to serve 20 and 40 students, respectively. Participants and high school student-mentors are identified through GVS/WCS faculty and staff recommendations. Erica Grantier serves as coordinator for both sites.

Research has demonstrated that students involved in a mentoring program are more confident and caring and significantly less likely to fight, skip school, or abuse drugs or alcohol.

This past year the Foundation's Grant Committee reviewed a record 26 competitive requests for funding, making full or partial grants to twenty applicants and declining six.

### **Belmont Free Library**

The Allegany County Area Foundation recently presented the Belmont Free Library with a check for \$750 for use in a project to renovate the library building's second floor.

Founded with forty volumes in 1885 and at home in its distinctive "flatiron" building since 1904, the library is a Belmont landmark. Local history suggests that the library construction was funded by industrialist Andrew Carnegie. For decades the building's spacious second floor served as a local gathering place-hosting dinners, meetings, dances, and celebrations.



Over time, other uses took priority, and communal use faded. This project is returning the second floor to a practical town gathering space, while bringing back more of its original look. The ACAF grant will be used for the purchase of a refrigerator necessary for hosting large groups.



### **Bolivar Free Library**

The Bolivar Library is one of several in Allegany County that were funded in whole or part by industrialist Andrew Carnegie The Allegany County Area Foundation presented a \$1400 grant to the Bolivar Library to assist with efforts to digitize its collection of *Allegany County Democrat* newspapers.

Published from 1867–1965 (initially as the *Allegany Democrat*) and with the tagline Fearless and Independent (see photo), the papers offer a look at happenings around the county and insight into local social and economic history. The papers will be a great resource for genealogists, teachers, town historians, and anyone researching the development of Allegany County.

The library's collection spans the years 1874-1963 (with the exception of 1909 –1923). Digitization is underway; the ACAF grant will help finish the project. The collection will be viewable via electronic media.

In addition to the *Democrats*, the library has 70+ years' worth (1892–1956) of another local paper, *The Bolivar Breeze*. These are indexed and exist now in hard copy and on microfilm. The library hopes to eventually have these also in an electronic format.

### **Alfred-Almond Community Sports Associates**

The Allegany County Area Foundation awarded \$1000 to Alfred-Almond Community Sports



Associates for the construction of the Greg Norton Memorial Park in the village of Almond.

The park project includes basketball and multi-purpose courts, a well-equipped playground area, seating, security features, and a pavilion. "At present" notes AACSA committee member Dan Hegarty, "there is no playground within the Almond Village. This will provide children with a safe place

to play." AACSA, which will look after and maintain the park, has managed local youth sports leagues for many years.

"This is a well-planned and organized project that will really benefit the community," ACAF's Bruce Campbell notes; "the Foundation is glad to offer this support."

### **Cornell Cooperative Extension**

The Allegany County Area Foundation recently presented a \$600 grant to the Cornell Cooperative Extension's Allegany County office for the development of a 20-C (Commercial) kitchen. This new kitchen is part of the FLAVOR project, which promises to benefit Allegany County citizens in several ways.

Expected to be in place by fall, the CCE's commercial kitchen will allow for new and in-

creased programing. CCE Executive Director Laura Hunsberger cites potential growth of their Expanded Food and Nutrition Education program (EFNEP), which promotes healthy eating and nutritional literacy, as a primary benefit.

Additional youth programs through 4-H and new classes in things like food science and safety, food processing, and cooking and canning will also be possible.



In addition to serving students, the FLAVOR project will work with a variety of area nonprofits and the agricultural community, including farmer's markets. The upgraded facility will also offer Allegany County CCE the opportunity to host regional 4-H and EFNEP activities.

### **Genesee Library**

The Allegany County Area Foundation made a spring 2019 grant of \$700 to the Genesee Library (Little Genesee) for the creation of dedicated Youth Enjoyment Spaces. These funds have already been put to good use, creating kid-friendly areas and activities through the purchase of furniture, a "Fishing for Literacy" carpet (see photo) and storage/organizer units.

The Spaces, which are up and running, have been well-received. "The new sections in the library are wonderful and I can't thank you enough for selecting us" reports librarian Raeanne Smith. "We are so proud of what we are becoming."

The library is newly approved as a summer lunch distribution site, which will introduce a greater number of area children and families to all the library offers, including the Youth Enjoyment Spaces.

Bruce Campbell, Executive Director of the Foundation, notes that good things are happening at the library. "The Genesee Library is doing a lot to expand its service to the community; we're really glad that we can contribute to that effort."



### David A. Howe Library

The Allegany County Area Foundation presented a \$500 grant to the David A. Howe Library for the reupholstering of the Library's armchairs.

Original to the building (1937), the chairs are found primarily in the Library's Local History Room, which houses historical and genealogical records and serves as a meeting place for organizations and groups from throughout the area. The chairs have been redone with a look that's in keeping with their 1930s vintage.



The grant was provided by the Foundation's Allegany Fund.

The largest public library in Allegany County and a member of the Southern Tier Library System, the David A. Howe Library holds over 110,000 items in its collection and is a New York State Document Depository.

### **CHRISTIAN and MOOGAN GRANTS**

### Allegany County Historical Society & Hart Comfort House

The Allegany County Area Foundation recently awarded grants of \$500 to the Comfort House of Allegany County (Hart Comfort House) and \$391 to the Allegany County Historical Society to support the purchase of new computers. The grants were provided through the Foundation's Allegany and Robert Christian Funds, respectively. The latter has as its focus efforts to preserve and share local history.

Hart Comfort House (hospice) will use its new computer for ongoing recordkeeping, administrative activities, and for the coordination of the organization's volunteers.

The Historical Society will put its improved technology to work tracking its growing collection – it will be especially helpful in creating electronic copies of historic documents and photos.



### **Southern Tier Traveling Teacher**

The Allegany County Area Foundation awarded \$476.55 to Southern Tier Traveling Teacher, Inc. These funds were used to purchase audio CD versions of TABE 11/12 (Test of Basic Adult Education) exam materials. The CDs align with upcoming content changes in state testing and will serve students with learning disabilities.

This grant was provided by ACAF's Thomas and Laura Moogan Fund, which was endowed in 1993 by the Moogans to assist local charitable and educational organizations.

Wellsville-based STTT was founded in 1984 and employs four staff that travel throughout Allegany County meeting clients in their homes or other mutually convenient settings to provide literacy and basic academic skills training, along with high school equivalency preparation. Clients range from homebound youth to older, out-of-school adults. Increasingly, too, STTT assists individuals with career activities, including resume writing, interviewing, and related job search skills.

STTT also coordinates the Allegany County high school equivalency graduation ceremony.

As of July 2019, the Allegany County Area Foundation manages 37 scholarship funds and 23 grant funds

### **NEW FUNDS**

### M. Gretchen Probst Scholarship

Established by Gretchen Probst in 2018, this scholarship will assist high school seniors or college students pursuing one of the following programs: electrician, masonry, carpentry, auto or truck mechanics, plumbing, HVAC, or the BOCES LPN program.

This year's first-ever recipients are Ambria Hopkins and Aaron Holmes.

### Shirley J. Weatherly Grant

This May, ACAF awarded the first ever Shirley J. Weatherly Grant, which goes to a Cuba-Rushford senior/graduate who has overcome challenges through perseverance and hard work.

Bree Kus is the initial recipient of this grant. Bree's aspirations are focused on graphics, photography and design. She pursued these interests at the Belmont Technical and Career Center during high school and will continue doing so at Alfred State College.

### **Delores Ackerman Scholarship**

A graduate of Wellsville High School and Alfred State College, Delores served

ASC in various positions for over 20 years. She was also employed by Allegany County. Delores served on school boards at the local, state, and national levels. This scholarship was established by her family, friends and WCS classmates in her memory; its two awards will benefit an aspiring teacher, and a WCS senior or graduate pursuing business study. These were

given for the first time this year. The future teacher recipient is Kaitlyn Allen (photo). Autumn Bledsoe received the business student award.

### **Allegany Senior Foundation**

ASF established a fund with ACAF. This endowment will provide an annual income to ASF in support of its activities and programs that serve Allegany County senior citizens.
















### **NEW FUNDS**

### Fund for the Andover Free Library

ACAF is pleased to announce the creation of an endowed fund that will benefit the Andover



Free Library. Established by Andover native Robert Grossman, the Fund for The Andover Free Library will provide annual support for the library's collections, operations, and facility. Gifts from family and friends have added to this fund.

A 1956 graduate of Andover Central School, Bob earned a degree in ceramic engineering from Alfred University while working parttime at Vars' Pharmacy. He then entered the US Army (2LT Armor), where he served for 21 years, including two tours in Vietnam

and several years in Washington DC. Retiring as a Lieutenant Colonel, Bob joined United Services Life Insurance Company, from which he retired as Vice-President of Marketing.

Bob's appreciation for the library is derived in part from his friendship with former librarian Rema Baker. "I visited her weekly all during my college years", he recalls. "Rema had me culling books in the library for many months and I became very knowledgeable of the library."

Library Director Linda Adams notes that private support is vital to small public libraries and is "always put to great use. It helps keep the collection up to date and the doors open. It's awesome when people from Andover who have relocated still remember the community."

### Anne McAndrew Teaching Scholarship

Thanks to the generosity of retired teacher Anne McAndrew, Wellsville's future educators will get some extra financial support as they prepare for the teaching profession.

Working with the Allegany County Area Foundation, Anne has established the Anne McAndrew Teaching Scholarship. Recipients will be selected on the basis of academics, recommendation, and overall potential to become an outstanding teacher, with priority for those planning to teach at the elementary level. The award may be renewed for up to four years, and through ACAF's membership in Dollars for Scholars, it will be matched by some colleges. In May, WCS grad/ Keuka College student Christina Good became the first-ever recipient.

For Anne, the scholarship is an acknowledgement of the teachers who inspired her interest in teaching and a way to encourage and assist a WCS graduate pursuing the career she so enjoyed. "As a teacher," she notes, "I experienced the satisfaction, joys, and challenges of being part of the learning of and growth of students. I wanted to create a scholarship that would assist a Wellsville graduate in pursuit of a teaching degree." Anne devoted thirty-five years to Wellsville Schools, twenty-four of those teaching




